K.T.T. PRE-ADVISE INSTRUCTION LETTER TO BE RETYPED ON THE SELLER'S LETTERHEAD, SIGNED BY SELLER AND CONFIRMED BY SELLER'S BANK BULLION OFFICER, IN CASE OF SELLER'S ANONYMITY RETYPE ON SELLER'S BANK LETTERHEAD WITH THE SIGNATURE OF TWO (2) SELLER'S BANK BULLION OFFICERS.
